In view of exigent conditions due to Covid-19 pandemic resulting in unprecedented increase in medicine/consumable/service rates, State Health Agency hereby temporarily revises Covid-19 package rates for specified Empaneled Health Care Provider(s) to ensure equitable health service delivery to Ayushman Bharat beneficiaries at empanelled healthcare providers (empanelled under General Medicine specialty) in Madhya Pradesh.
